Denton Avenue School - 1050 Denton Ave - New Hyde Park, NY 11040

The 2017 New Hyde Park-Mineola 8K is USAT&F Certified 8K (4.97 miles) course through suburban streets of New Hyde Park. Nassau County Police traffic control. Splits every mile and 3 water stops. This is a **USAT&F-Long Island Individual and Team Championship Race** and is part of the Grand Prix Championship Series.

Meadowbrook Parkway to Northern State Parkway (West) bear right at the first exit "Glen Cove Rd, South, Hempstead". Turn right on Hillside Ave. 2.9 miles to Denton/Marcus Ave. Turn right. The school is on the right.
