### COURSE

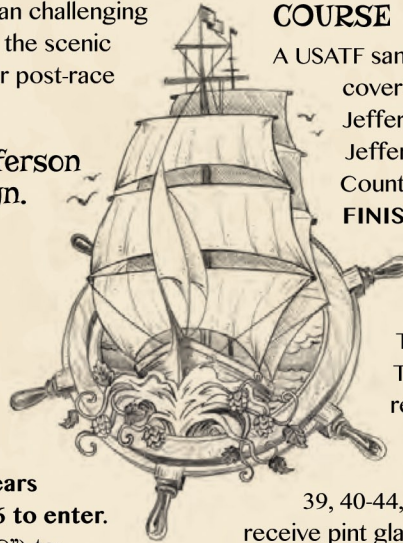
